Miller Creek Neighborhood Council General Meeting Minutes

September 10, 2024; 6pm

Malony Ranch Park

Attendance was about 55. Smoke filled air deemed unhealthy and a Presidential debate happening at the time of the meeting.

Aaron Wilson spoke about the Traffic Planning Committee process to address the 200 projects being evaluated in Missoula. There's 20 to 30 metrics to evaluate the 200 projects and place the priorities over a 20 to 30 year plan. He brought a map and charts to demonstrate the committee work being done. Mountain Line has changes planned over the next 5 years, to possibly add an On Demand type of service. Public Open House meetings are being planned to collect comments. Comments can also be submitted online via the Mountain Line website. Kevin Slovarp and Jeremy (?) spoke to a question about alternative exit/entry routes to and from Miller Creek. Public meetings will be held concerning the Round-About at Riverfront Trails Subdivision development, and Special Improvement District fees.

Lee Boman spoke about the Miller Creek Action Plan & Survey. The surveys could be handed in at the General Meeting or taken to The Den to be collected.

Ashley and Emily spoke about the Growth Vision for Land Use in Missoula. They encouraged everyone to get engaged with the Land Use process.

Stacie Anderson and Bob Campbell gave updates regarding Urban Camping, the Fire Levy, deer mitigation, the July storm affecting 75% of Missoula trees. A Rexburg, Idaho Biomass plant with FEMA help is purchasing part of Missoula's fallen tree & limb waste. They also spoke about ADU (additional dwelling units) being put into a Montana State Legislation Bill. ADU's are being looked at for the University District

Also, a Bear / Deer Task Force has been created at the City level.

Alex Fregerio spoke about the Action Plan monies. Alex introduced current MC Leadership Team and told the group that we need a new Treasurer on the Leadership Council & that we welcome everyone to attend our monthly Council meetings. Current Officers were reelected with the exception of Holly Haslam.

Gift cards were raffled off.
