1. Action Plan Survey update given by Lee, 39 surveys were returned via online & The Den. He stated that we need to generate more returned surveys. Suggestions are: Upper Linda Vista HOA be contacted, Melissa to email the survey to the Miller Creek Neighborhood 2 different times, and post the QR code on grouped mail boxes. Diane will contact JR School to send surveys home with students. Deadline to complete the survey is September 30th.

2. General Meeting Review:

- 55 in attendance, related to smoky air and Presidential Debate. Meeting ended by 7:45pm.
- Next year, Alex stated the sandwich boards need to have Meeting info printed on High Visible colored paper. Also a topic for next year can be the Capitol Improvement Project.
- Melissa stated that some Neighborhood groups have door hangers made to advertise the General Meeting. In the past we have spent \$700 to \$800 to mail out postcards.
- Melissa reports that they now have generator to run the speaker system for the General Meetings.

3. Community Forum Report:

- Medora will virtually attend the meeting on September 26th.
- Lee stated that 100% of the prior Forum was about the Urban Camping Ordinance for the Unsheltered community. More information is available online at Engage Missoula website.

- Melissa stated that the Grant Application is now open with a November 20th deadline to submit the requests, (grant proposals).
- There's a City Government training meeting available on October 8th at 5:30pm.

- The Den (Dennis, Manager) is interested in opportunities to improve BrookLynn City Park, and is open to ideas & suggestions as it would benefit the neighborhood and his business.
