Presentation by Mike from Home Resource:

Home Resource has partnered with Public Health to offer safe disposal of Household Chemical Hazardous Waste. This includes old pesticides, herbicides, bleach, paint, and mercury thermometers. Only household hazardous waste will be accepted. Those wishing to get rid of hazardous waste, need to make an appointment. This is accomplished on their website. 10 gallons to dispose of costs \$20. No oil, or batteries are accepted. There are certain days and times for appointments. (20 appointments per day) Check the Home Resource website for more information.

Minutes of the previous meeting were approved.

Action Plan: We approved the draft of our Neighborhood Action Plan as presented by Alex. We discussed our message board being placed beside the mailboxes at Brooke Lynn park. Upper Linda Vista HOA will not be able to do any maintenance of the message board. We proposed a group meeting with other neighborhoods wanting to place a Message Board in their neighborhood parks, and have Lincoln Lake or other Park & Recreation member present, to discuss the details of our Action Plan. We want to create a uniform design and purpose of the Message Board.
