- August 12th minutes approved. Minutes from May are lost, removed from agenda
- Leadership Team voted to remove Bernadette Baily, as she has been unable to make a meeting and this has been affecting quorum. Bernadette is welcome to rejoin when she has more availability.
- Leadership Team voted to move meeting times to the first Thursday of the month, time and place will remain the same.
- Resilience Fair debrief: all agree that this went well. There was a lot of enthusiasm and engagement from local businesses and organizations. Tablers reported good interaction with neighborhood residents. Greeters were very helpful. There has been some discussion that the Leadership Team and NIA will not do another large event next year due to the time commitment, but this will be reviewed further at a later date.
- Community Forum Report from Clint: MRA gave a presentation updating on their various projects. September's meeting will discuss the Downtown Safety, Access, and Mobility Project. October's meeting will discuss Code Reform. Meetings are recorded and are available on the City's website.
- City Council report will be on September 15th, Will has volunteered to do this. Topics will be a review of the Resilience Fair, Goal setting for the Neighborhood, and continuing to follow up with the MRL Triangle project. Jenn will do the December 8th report.
- Neighborhoods Report from Kalina: The final outreach for the Reserve Street Safety Plan will be this fall. Energizer Grant applications are live, the deadline for proposals is November 26th, with grant writing workshops in October. There is \$35k available for grants this year. The League of Women Voters will be holding Candidate Forums for Municipal Elections on September 30th (Wards 1,2), October 2nd (Wards 3,4), October 16th (Wards 5,6), and October 21st (Mayoral).
