Motion: The committee recommends that the City Council approve the 2010-2011 STEP overtime grant for DUI and seatbelt enforcement

Greg Amundsen described the \$25,000 STEP grant that is used by the Police Department to fund DUI and seatbelt enforcement overtime.

Pam Walzer asked if the grant needed to be approved by the Council.

Dave Strohmaier noted that the agenda item did not indicate if a motion was in order.

Greg Amundsen did not know if the grant needed to be approved by the Council.

Jon Wilkins thought that the grant needed approval.

Greg Amundsen stated that Laurie Clark told him that a public hearing was not necessary for this grant. Greg seemed to think that the grant needed approval by the City Council due to the dollar amount.

Jon Wilkins moved to approve the grant.

Pam Walzer asked if the additional overtime funded by the grant compromised the readiness of the Police force

Greg Amundsen provided statistics, and he did not believe that the overtime compromised the readiness of the Police force. He cited the eagerness of officers to work the overtime shifts.

Dave Strohmaier asked Greg Amundsen to describe the current grant STEP in context to prior STEP grants.

Greg Amundsen responded that the Police Department has been receiving the STEP grant for 5 or 6 years. In the past, the amount has ranged from \$25-30,000, and last year it was \$35,000. This year's grant was reduced to \$25,000 due to a reduction in Federal funding.

Motion approved unanimously.
