MOTION: THE COMMITTEE RECOMMENDS THE CITY COUNCIL ADOPT A RESOLUTION AUTHORIZING THE MAYOR TO SIGN AGREEMENTS AND UTILIZE \$18,500 OF GRANT FUNDS ALLOCATED THROUGH NORTHWESTERN ENERGY E+ BUSINESS PARTNERS PROGRAM TO ENHANCE ENERGY EFFICIENCIES IN THE CURRENTS AQUATIC CENTER NATATORIUM.

The meeting was called to order at 10:05. Marilyn Marler read the agenda item and added that the resolution authorizes the mayor to sign a contract with Northwestern Energy for grant funding of this project. She said she supportive of the project as it offers substantial energy savings.

Shirley Kinsey, Recreation Manager, Missoula Parks and Recreation, said the project saves additional energy and reduces wear and tear on the HVAC system at Currents. The VFD would allow the system to regulate itself continuously to maintain optimum humidity in the natatorium, which will save energy and reduce the need for system shutdown after hours. She stated that the VFD acts like a throttle on the HVAC system, allowing the system to adjust its energy use as needed.

Councilman Wilkins asked how much was left in the Aquatics Reserve Fund. Kinsey stated that she did not have the budget figures in front of her at the meeting and would be reluctant to answer without documentation available. She said she would send Mr. Wilkins that information as soon as possible.

Marler called for the question or for further comments.

Councilman Childers made a motion that the authorizing the Mayor to sign agreements with Northwestern Energy and contractors who will install the variable frequency drive (VFD) at Currents. He said he liked the idea that the project will save \$4000 to 5000 per year in energy costs and reduce wear tear on Currents' HVAC system.

The motion carried unanimously.
