Summary Description and rationale of project and funding sources:								
<p>The City and Missoula County seek to jointly acquire the Missoula Federal Building and rehabilitate the building to serve as City Hall and County central services. Design work for the project will span FY 22 and FY 23. We anticipate taking title to the building in FY 23, and commencing phased construction work as soon thereafter as is feasible. The City faces an urgent need for additional space in order to deliver public services, and will, in the absence of investment in the Federal Building, need to spend as much or more to otherwise respond to space needs. Funding for FY 22 design work will probably need to be from the general fund. Staff will explore other potential funding sources for design, and will develop a funding plan for rehabilitation that may include sale of current City properties, ARPA or other federal grants, reappropriation of current leases, limited obligation bonds, leasing, or tax increment financing.</p>								
History & Current Status: Impact if Cancelled or Delayed								
<p>If cancelled, the City will need to develop an alternative strategy and funding plan to meet space needs, such as expansion and rehabilitation of City Hall, additional leasing, etc. Delay of design would delay rehabilitation; design is projected to take at least until acquisition of fee title. Delay of rehabilitation will delay improved delivery of public services and extend costs for leased space.</p>

<p>The project requires extensive coordination with federal agencies, Missoula County, the State Historic Preservation Office, and interested members of the public.</p>
