1. How will request assist in achieving Department Goal and benefit the customer

In the last several years, The City of Missoula has experienced a surge in development review activities that have prevented us from providing the level of responsive service the community has come to expect. These delays in development review have also had a negative impact on new construction of houses and apartments, working against the goals outlined in our adopted housing policy and City of Missoula Strategic Plan. In FY22, CPDI engaged in process auditing and assessment to identify improvements within our permitting software that would enhance service, improve timeliness for the development community, and increasing efficiency for our team members.

2. What specifically is needed to achieve this goal?

Well over 1,000 individual permits of various types, including all business licenses and excavation permits, have not yet been automated. These "paper submission" processes are cumbersome and time consuming for team members and add days, if not weeks, onto the process for businesses and the development community. This request will allow us to move forward with automating these processes in our Acela permitting software, along with making efficiency improvements and upgrades to existing automation tasks. This one-time request will have a dramatic effect on efficiency, allowing our teams to dedicate more time to the issuance of permits that directly impact our housing market and is a smarter and more strategic investment than adding more staff positions.
