Summary Description and rationale of project and funding sources

Downtown Lions Park is part of the adopted North Riverside Parks and Trails Master Plan. Since plan adoption, Native Americans Against Drugs and Alcohol (NAADA), All Nations Health Center, Great Western Recreation, and Parks and Recreation have begun a partnership to implement the Master Plan and create a safe and welcoming space that celebrates modern indigenous culture and provides healthy activities for young adults. Improvements include a basketball half court, an activated play space, a portapet, art, and lighting. □

History & Current Status: Impact if Cancelled or Delayed

The North Riverside Parks and Trails Master Plan was developed in 2020. In 2021, Native Americans Against Drugs & Alcohol (NAADA) selected the park as a space to improve community health outcomes. NAADA, Parks & Recreation, and the University of Montana applied for a grant for the park that was not funded. Parks & Recreation, NAADA, and All Nations Health Center partnered with Great Western Recreation to receive discounted park amenities. In 2022, Parks and Recreation hosted a series of listening sessions in collaboration with All Nations Health Center. The project stalled briefly when the city acquired the Flynn Lowney Ditch, a portion of which runs through the park, and there was an opportunity to align the goals of the two projects. It is important not to delay the project further because of the time limit on receiving discounted goods and services from Great Western Recreation.□
