Summary Description and rationale of project and funding sources:									
<p>This half mile long segment of the South Hills Trail system is a designated Safe Route to School serving Meadow Hill Middle School. The trail segment was built in 2006 using CTEP federal funding. The paved trail is 8' wide. The trail tread is in very poor condition due to age, type of asphalt used, lack of cyclical maintenance, tree roots, cracking, and ravel. The trail segment project provides for removing existing asphalt, treating root damage, refreshing the base, and repaving to an 8' width using a Type C pavement. The project addresses safety and potential liability concerns and will restore the quality of the trail tread for an improved user experience. Transportation Alternatives Pavement Preservation funding is available for this project.</p>									
History & Current Status: Impact if Cancelled or Delayed									
<p>Major renovation is needed to address poor condition of trail asphalt, tree root damage, minor drainage concerns, and user safety. Federal Transportation Alternatives funding for this pavement preservation project are available. Cancellation or delay will not address safety and liability concerns and could affect Federal funding allocation, leverage value. Project costs will increase over time if not funded.</p>

<p>Parks and Recreation will work with Missoula County Public Schools to minimize impact during the school year - primarily through scheduling.</p>
