Summary Description and rationale of project and funding sources:

Reconstruction to include curb/gutter/sidewalks, bike facilities, street lighting, and traffic calming. BaRSAA funding would be used to leverage MRA funds.

History & Current Status: Impact if Cancelled or Delayed

This project addresses safety and connectivity issues, implements a portion of the neighborhood greenway network, and supports affordable housing goals. Preliminary engineering design is complete for the south half and included substantial public/neighborhood outreach. The FY25 budget request is to update preliminary engineering plans for the north half (Wyoming to River Road). Final design would be completed in FY25 and construction in FY26-28.
