Summary Description and rationale of project and funding sources:									
This project is expanding the budget of a project approved in FY24 to replace a number of plug valves and check valves associated with the Recycle Activated Sludge (RAS) pumping facilities. The initial budget submitted was only to cover the cost of engineering and to pre-procure the valves. The budget submitted here is the additional budget amount required to complete the project. The project will be financed using a State Revolving Fund loan. This loan is in progress and will be closed once the project is bid and the costs are known.									
History & Current Status: Impact if Cancelled or Delayed									
This is a critical project that was just identified in the last year. RRF staff discovered that these plug valves and check valves were no longer functional, which prevents the RAS pumps from being isolated for maintenance.
