Summary Description and rationale of project and funding sources:								
<p>The City's wastewater collection system is aging and a regular program of rehabilitation (lining) or replacement is needed. The system includes over 330 miles of sewer main, of which 22 miles are more than 90 years old. The Wastewater Division would like to establish a target of 1% rehab/replacement per year (i.e. 3.3 miles). It will take time to develop a program and determine typical costs of rehabilitation and replacement. This CIP will also address decommissioning of Septic Tank Effluent Pump (STEP) system, where a gravity sewer option is available. The first two STEP decommissioning projects to be assessed will be the Southpoint STEP system and the Lamoreux Lane STEP system.</p>
