Summary Description and rationale of project and funding sources:								
<p>The rattlesnake greenway or "borrow pit trail" is a shared use path along Rattlesnake Drive in the Upper Rattlesnake neighborhood. This trail would replace the existing single track path that follows the street. Rattlesnake Drive in this location has no pedestrian facilities, yet is a heavily used pedestrian and cycling corridor. Providing a separate shared use path would match the existing character of the street, and provide much needed safe pedestrian facilities that would connect existing neighborhoods with pedestrian facilities further down the valley, creating a safe route to school.</p>								
History & Current Status: Impact if Cancelled or Delayed								
<p>This project has been an important goal of the Upper Rattlesnake neighborhood for years. In 2009 a Missoula Neighborhood Grant was awarded to hire an engineering firm to look at the feasibility of constructing this trail. The project has been on the list for years, and as time goes on costs continue to escalate, resulting in a more and more expensive project.</p>
