THIS CONVEYANCE is made as of this _____ day of _____, 20____

by and between _____, with the address of _____, ("Grantor"),
and the City of Missoula, a municipal corporation organized pursuant to the laws of the State of Montana,
whose address is 435 Ryman Street, Missoula, MT 59802 ("Grantee").

KNOW ALL MEN BY THESE PRESENTS THAT Grantor, owner of the property legally
described as: (Legal Description Below)

does hereby grant and convey to Grantee an exclusive Public Right-of-Way Easement to operate
and maintain a public roadway and other right-of-way usages over, upon and across a portion of the
Property. Said easement over and across the Property being more particularly shown on Exhibit
A, which is by this reference made a part hereof (the "Easement Area").

TO HAVE AND TO HOLD the above described Public Right-of-Way Easement subject to the
following terms and conditions:

Grantee Rights. The Easement shall include the right, privilege, and authority of Grantee to
construct, install, maintain, repair, operate, and replace roadway and transportation infrastructure in
the Easement Area, along with the right to install, construct, operate, repair, and maintain, or permit
others to do the same, public and private utilities upon, over, under and across the Easement Area.
This Easement shall also include the right of Grantee to provide regulatory enforcement of
applicable state and local laws within the Easement Area.

Grantor Obligations. Grantor agrees to maintain any curb, sidewalk, and boulevard in the right-
of-way in accordance with City of Missoula Municipal Codes. Grantor agrees not to build any
kind of permanent structure on the Property that will prevent access to the Easement Area for
maintenance purposes.

Grantee Obligations. Grantee agrees to supply all materials, labor and equipment to maintain and
repair the herein described right-of-way pavement surface (excluding street reconstruction) and
provide sweeping and snow removal consistent with municipal services provided to other
residential and commercial areas of municipal right-of-way. The Grantee agrees that future
reconstruction of the herein described right-of-way street surfaces will be provided in a similar
manner as provided throughout the remainder of the City of Missoula right-of-ways. The Grantee
agrees to provide regulatory enforcement of the usage of this public right-of-way in accordance
with City of Missoula Municipal Codes applicable to public right-of-ways.

Warranty. The Grantor acknowledges that they are the lawful owner(s) and seized of the real property over which and upon the easement described herein are granted, and that they have good and lawful right and authority to grant said easement.

Binding Effect. This grant of Easement, which shall be recorded at the Missoula County Clerk and Recorder's office, is binding upon the heirs, executors, personal representatives, assigns and successors of the parties hereto and shall run with the land.
