


How will the City's budget affect my taxes?

Mayor Davis has proposed a 3.5% increase in City taxes for fiscal year 2026

- This only affects the **City's** portion of your property tax bill
- Due to legislative changes, many properties will have **lower City taxes** than last year, despite the 3.5% increase

City Taxes for Tax Year 2025 (City's Fiscal Year 2026)

Key Points

- The Montana Department of Revenue reappraised properties this year
 - In Missoula County, the **market value*** of a **median-priced home** increased 27% (from \$399,000 to \$507,000)
 - Some properties will see more than a 27% **market value** increase and some will see less – this is only the **average** increase for the county
- The 2025 Montana Legislature changed **tax rates** for this year
 - Many homes will have a lower **taxable value** than last year, even if the market value went up
 - **Taxable value** is the important number for calculating your City taxes

*Note that the DOR market value does not typically match current median sales value from other sources. In the current appraisal cycle, the Department of Revenue shows that the median market home value in Missoula County was \$507,000. The Missoula Organization of Realtors shows the current median home price at \$560,000.



Estimating your City Taxes for a Property

Taxable value x 0.36583 = City taxes*

Example 1 – Median Home



- The new, lower tax rate means that this home has a **lower taxable value** than last year
- This property will pay **less** in City taxes than last year



Lower

- The market value of this home went up by over 20%
- The new, lower tax rate means that this home has a **lower taxable value** than last year
- This property will pay **less** in City taxes than last year



Lower

- The market value of this home went up by nearly 30%.
- The new, lower tax rate means that this home has a **lower taxable value** than last year
- This property will pay **less** in City taxes than last year

Taxable value	\$5,685.00	\$4,633.00	(18.5%)

City Taxes

2024: \$1,868.01

2025: \$2,122.91

\$254.91 Higher



- The market value of this home went up by nearly 60%.
- The new tax rate mitigated the taxable value increase, but the **taxable value still went up**
- This property will pay **more** in City taxes than last year

- These two properties are across the street from each other
- Both **increased** in market value and they have similar taxable values
- One will pay **higher** taxes than last year, and one will be **lower**
