

## **\$6,668,245 Housing**

- **\$4,071,357 Emergency Housing**

“Operation Shelter” started in 2021 as a short-term, focused response to the negative economic impact and harm experienced by our unhoused community and greatly exacerbated by the COVID-19 pandemic. The project includes several facets: an Emergency Winter Shelter (September 2023 - August 2025), authorized camping space (closed Nov 2022), a temporary safe outdoor space (TSOS), a Community Care Team for persons utilizing services, and operational support for the Poverello Center, our local homeless shelter. The City has also contracted with local security providers to help keep all shelter spaces safe and ensure residents at each location feel secure. - **\$1,050,000 Affordable Housing Trust Fund**

The Affordable Housing Trust Fund (AHTF) was created in July of 2020 as Missoula’s local source of funding to both meet the city’s urgent housing needs and establish long-term affordable housing for Missoula. ARPA is providing a financial boost to AHTF’s annual \$100,000 budget. To learn more, visit the [AHTF website](#).

ARPA funded AHTF grants include:

- \$106,250 for the Centralized Housing Solutions Fund/United Way
- \$190,250 for Habitat for Humanity modular home acquisition
- \$340,000 to the North Missoula Community Development Corporation (NMCDC) for land acquisition for the Wolf Street Housing Co-op/CLT
- \$35,000 to Homeword for the Home Ownership Center, an ongoing program to empower individuals with low-to-moderate incomes through financial and homebuyer education and counseling programs
- \$40,000 administrative capacity building for North Missoula Community Development Center (NMCDC)
- \$274,275.50 to Homeword for Creekside Apartments rehabilitation

- **\$834,000 Poverello Center VA Transitional Housing**

ARPA funding supported the Poverello Center with property acquisition for their Housing Montana Heroes transitional housing program for Veterans. The Poverello Center has purchased the Clark Fork Inn on West Broadway as the site. This project is also receiving financial support from City of Missoula Brownfields funding, Missoula County, State Community Development Block Grant (CDBG) funding and a grant from the U.S. Department of Veterans Affairs (VA).

- **\$479,435 allocated to Ravara Development, LLC for design costs for the Community Land Trust located at Scott Street.** Read more on the [Engage Missoula Scott Street Development](#) page.

- **\$233,453 Houseless Initiatives Staffing Capacity**

This boost to staffing infrastructure started in 2023 and included defining and implementing a plan to staff and operate the Trinity Navigation Center, continued support for ongoing Operation Shelter work, and anchor institution support for the [Missoula Coordinated Entry System](#).
